BY THE BOARD:

By letter dated November 15, 2012, Time Warner Cable New York City LLC, d/b/a Time Warner Cable ("TWC" or the "Company"), requested a waiver of the 30-day notice period for the filing of a revised schedule of prices, rates, terms and conditions pursuant to N.J.A.C. 14:17-6.16.

Time Warner maintains that the waiver request is necessary because it did not file the revised schedule of prices, rates, terms and conditions with the Office of Cable Television ("OCTV") in sufficient time to comply with the 30-day notice requirement of N.J.A.C. 14:17-6.16. Along with the November 15, 2012 waiver request letter, Time Warner filed a revised schedule of prices, rates, terms and conditions with the OCTV with an effective date of December 15, 2012. Because the revised schedule was received on November 16, 2012 with a December 15, 2012 effective date, it was one day short of meeting the requirements of the 30-day notice period. Time Warner claims that because of the restoration efforts expended by Company personnel after Hurricane Sandy pertinent company personnel was unable to devote the attention to timely preparation of the revised schedule resulting in the inability to meet the 30-day notice requirement.

Time Warner requests that the Board permit the filing of the revised schedule with and upon 29 days' notice given that the public interest would not be harmed and it will have no adverse impact on subscribers or municipalities.


N.J.A.C. 14:17-6.16(a)(4) requires each cable company to provide the OCTV with "[a] statement as to the date on which it is proposed to make the schedule of all prices, rates, terms and

conditions or change effective" at least 30 days prior to the effective date, unless otherwise permitted by the OCTV with the approval of the Board.


Having reviewed this matter, the Board HEREBY FINDS that the waiver is appropriate under the present circumstances and accordingly grants the requested waiver for good cause. Therefore, the Board HEREBY APPROVES Time Warner's request for a waiver of the filing requirements as previously described.




