TECHNICAL CONFERENCE

IN THE MATTER OF THE IMPLEMENTATION OF FEDERAL INFLATION REDUCTION ACT HOMES (HOME EFFICIENCY REBATES) AND HEEHR (HOME ELECTRIFICATION AND APPLIANCE REBATES) PROGRAMS

DOCKET NO. <u>Q023100733</u>

Staff of the New Jersey Board of Public Utilities (NJBPU or Board) hereby gives notice and invites all interested parties and members of the public to participate in a Technical Conference to discuss the design of the program to implement the federal Inflation Reduction Act Home Efficiency Rebate (HOMES) and Home Electrification and Appliance Rebates (HEEHR) formula funding, as described further below.¹

Background and Procedural History

On February 15, 2023, Governor Phil Murphy signed Executive Order 316 directing the State to advance the electrification of 400,000 additional residential dwelling units and 20,000 additional commercial spaces, and an additional 10 percent of residential units in low income communities to be made electrification-ready by 2030.² Executive Order 316 further directs the Board to ensure that the federal HOMES Program and the HEEHR Program are implemented and coordinated to support buildings electrification, with a primary focus on the needs of low- and moderate-income (LMI) customers.

Pursuant to the above directives of Executive Order 316, the Board initiated the above docketed matter, enabling Board staff (Staff) to engage with stakeholders to investigate and recommend how to design and implement a program to distribute the HOMES Program and HEEHR Program funding allocated to New Jersey under the Inflation Reduction Act of 2022 (IRA).³ Accordingly, Staff will consider the following with respect to program design and parameters:

- 1. Optimal pathway to calculating rebates delivered to the customer between modeled versus measured approaches recommended by U.S Department of Energy (DOE);
- 2. Developing a clean buildings workforce to deliver the HOMES Program and HEEHR Program funding, from the perspective of establishing long-term jobs;

- 3. Integration of the HOMES Program and the HEEHR Programs with existing energy efficiency and low- and moderate-income programs;
- 4. Approaches to designing programs serving multi-family buildings in low-income communities; and
- 5. Ensuring efficient delivery of these programs with respect to income verification, outreach and customer experience.

This Technical Conference concerns the implementation of federal HOMES/HEEHR formula funding, which will help New Jersey households save money on energy bills, upgrade to clean energy equipment, improve energy efficiency, and reduce indoor and outdoor air pollution. As such, the purpose of the Technical Conference is to discuss ideas about how best to deliver federal HOMES/HEEHR formula funding alongside current efficiency and electrification incentives in New Jersey and to explore related topics integral to delivering innovative and effective energy efficiency programs that help save ratepayers money and drive the State's reduction of energy consumption and emissions economy-wide. Through the Technical Conference, Staff will conduct the formal stakeholder engagement in the HOMES/HEEHR Energy Efficiency Incentives program development.
