 Investigation opened by the Board on February 17, 2021, following review of complaints from at least 10 municipalities on service issues of Altice USA, Inc.

Complaints include:

- frequent and lengthy service disruptions (across all services)
- inconsistent connections and fluctuating Internet speeds,
- Jong telephone wait times,
- poor customer service,
- inability to get a satisfactory response to these issues from the company both before and after the COVID-19 pandemic.
