


## **Background**

In 2009, ESIP was first signed into law as a financing method for New Jersey's boards of education, public institutions of higher education, local government units, and State contracting agencies to implement energy conservation measures ("ECMs") as set forth under energy savings plans ("ESPs") (P.L. 2009, c. 4). On September 12, 2012, P.L. 2012, c. 55 was signed into law, which amended and further defined the ESIP process.

The ESIP program is a form of energy performance contracting. It serves as funding mechanism for new capital investments for public entities to improve and retrofit their facilities with ECMs. This is accomplished by using the future value of energy savings to finance the up-front investment, which is paid back, over time, from the savings that accrue to the public entity through reduced energy bills. Approved applicants can execute up to 15-year (or 20 years with combined heat and power or cogeneration projects) contracts.

Guidelines for the ESIP program are currently in place. However, pursuant to the enabling statute and the Board's 2013 Order in Docket 13050418V, Staff intends to promulgate rules in accordance with Administrative Procedure Act, N.J.S.A. 52:14B-1 et seq. Staff started gathering stakeholder input in August 2020 with the first issuance of program policy discussion topics by Staff and continued with a stakeholder meeting on September 8, 2020. Comments were received on topics covering: process improvement; project components; RFP template; construction and finance; Phase II projects; guidance; and project savings guarantee. While not all of these topics may be directly discussed in the proposed regulatory language, Staff intends to build upon comments received from stakeholders as the ESIP program is improved.

With the Board's recent energy efficiency ("EE") transition, the ESIP program has continued to update to reflect changes in potential incentives and their availability to ESIP projects. The ESIP Program is separate from the Board's EE programs and may continue to refine its processes separate and apart from the EE transition.

## **Staff Straw Proposal**

Staff took into consideration all of the feedback from stakeholders and has prepared the attached straw proposal for discussion. It contains the provisions Staff envisions for a draft rule proposal. The straw proposal clearly delineates program rules as established in law, clarifies practices established through previous guidelines, and establishes processes to correlate with the recently implemented EE transition regarding reporting of EE savings, Board-approved energy efficiency programs, and demand response programs.

Staff is soliciting feedback on the proposed language from all interested stakeholders prior to issuance of draft regulations by the Board.
