## Background and Procedural History

As part of the NJBPU's second offshore wind energy solicitation, Atlantic Shores Offshore Wind Project 1, LLC, and Ocean Wind II, LLC committed \$10,000 per megawatt of project-size-awarded capacity – or approximately \$26.5 million – to fund regional research and monitoring to assess the impacts of offshore wind on New Jersey's natural resources. This funding established the <u>Initiative</u>.

The RMI addresses the need for regional research and monitoring of marine and coastal resources before and during offshore wind development, construction, operation and maintenance, and decommissioning as recommended in the New Jersey Offshore Wind Strategic Plan.<sup>2</sup> The NJBPU and the NJDEP jointly administer the Initiative through the RMI Steering Committee, an entity comprised of an equal number of members from the NJBPU and the NJDEP. The goal of the RMI is to ensure that as New Jersey moves toward a clean energy economy through the development of offshore wind, the State also protects and responsibly manages New Jersey's coastal & marine resources.

Research, collaboration, and stakeholder engagement went into the development of short-term, highest-priority research needs for the RMI. Having recently observed the one year anniversary of the RMI's inception, the RMI Steering Committee seeks input from stakeholders regarding the <u>short-term</u>, <u>highest-priority list</u>, which has been used to develop specific scientific questions within each research priority category and drive the identification of projects for funding from the RMI. The RMI Steering Committee also seeks input on additional RMI research priorities that align with the RMI's established <u>Principles and Objectives</u>.

### **REQUEST FOR COMMENT**

# A. Short Term Research Priorities

The current <u>RMI research and monitoring priorities</u> are intended to address short term research and monitoring needs. They primarily seek to establish baseline environmental and ecological datasets during the pre-construction phase of an offshore wind project to produce credible,

scientifically rigorous results that can be used for identifying, understanding, minimizing/avoiding, and/or mitigating impacts of offshore wind on marine resources, as well as evaluating efficacy of mitigation efforts.

- 1. After reviewing the list of RMI <u>research priorities</u>, are there additions or modifications that you would recommend to this list? If so, what are they?
- 2. With respect to the short term research priorities, how would you recommend that the State allocate RMI funding going forward?

## **B.** Future Research Priorities

- 1. What research priorities do you think should be included during phase 2 (construction phase, defined as commencing when the first New Jersey offshore wind farm infrastructure installation begins) of the RMI (i.e., what other research should be undertaken during the construction phase)?
- 2. What research priorities do you think should be included during phase 3 (operation phase, defined as commencing when the first New Jersey offshore wind farm achieves commercial operation) of the RMI (i.e., what other research should be undertaken during the operations phase)?
