*The Board will consider Atlantic City Electric Company's 2021 Non-Utility Generation Charge and Societal Benefits Charge rates. The parties have executed a stipulation for final rates, which if approved by the Board, will result in no additional bill impact to customers.*

*The Board will consider Atlantic City Electric Company's PowerAhead rate roll in. The parties have executed a stipulation, which if approved by the Board, will result in an increase in the monthly bill of a typical residential customer of \$0.10.*
