BY THE BOARD

By letter dated April 1, 2013, Comcast Cable Communications, LLC, ("Comcast"), requested a waiver of the 30-day notice period for the filing of a revised schedule of prices, rates, terms and conditions pursuant to N.J.A.C. 14:17-6.16.

Comcast maintains that the waiver request is necessary because it did not file the revised schedule of prices, rates, terms and conditions with the Office of Cable Television ("OCTV") in sufficient time to comply with the 30-day notice requirement of N.J.A.C. 14:17-6.16. Along with its April 1, 2013, request, Comcast filed a revised schedule of prices, rates, terms and conditions with the OCTV with an effective date of May 1, 2013, for the purpose of increasing the equipment fee for business class Internet service from \$7.00 to \$9.95 for all of its New Jersey systems. However, because the filing was not received until April 2, 2013, it was one day short of the required 30-day notice requirement.


Comcast asserts that, pursuant to N.J.A.C. 14:18-3.16, subscribers and municipal officials for all New Jersey systems were properly notified of the change by mail in sufficient time to comply with the 30-day notice requirement.


N.J.A.C. 14:17-6.16(a)(4) requires each cable company to provide the OCTV with "[a] statement as to the date on which it is proposed to make the schedule of all prices, rates, terms and conditions or change effective" at least 30 days prior to the effective date, unless otherwise permitted by the OCTV, with the approval of the Board.


Having reviewed this matter, the Board **HEREBY FINDS** that the waiver is appropriate under the present circumstances. Comcast notified subscribers and affected municipalities of the revisions to its schedule of prices, rates, terms and conditions at least thirty days in advance of the effective date of the change which comports with N.J.A.C. 14:18-3.16. Therefore, the Board **HEREBY APPROVES** Comcast's request for a waiver with respect to adequate notice to the Office of Cable Television, as within time.


