PLEASE TAKE NOTICE that on December 28, 2023, Comcast of Northwest New Jersey, LLC filed an Application with the New Jersey Board of Public Utilities ("Board"), Office of Cable Television & Telecommunications, requesting a system-wide franchise ("SWF") to offer cable television service in the Boroughs of Bloomsbury and Frenchtown, located in Hunterdon County, New Jersey ("the Boroughs"). Comcast of Northwest New Jersey, LLC currently serves a total of 17 municipalities under its traditional municipal consent-based cable television franchise.
