

**NOTICE TO JERSEY CENTRAL POWER & LIGHT COMPANY CUSTOMERS**

**IN RE THE VERIFIED PETITION OF JERSEY CENTRAL POWER & LIGHT COMPANY FOR APPROVAL OF JCP&L'S ENERGY EFFICIENCY AND CONSERVATION PLAN INCLUDING ENERGY EFFICIENCY AND PEAK DEMAND REDUCTION PROGRAMS (JCP&L EE&C)**

**BPU DOCKET NO. EO20090620**

**PLEASE TAKE NOTICE** that, on December 5, 2023, Jersey Central Power & Light Company ("JCP&L" or "Company") filed a letter petition ("Petition") with the New Jersey Board of Public Utilities ("Board") seeking approval to extend JCP&L's Board-approved Triennium 1 ("T1") Energy Efficiency and Conservation Plan (the "EE&C Plan" or the "Plan") by six months to December 31, 2024, with a budget of \$69,290,584 for the extension period.

By Order dated April 27, 2021, the Board approved a stipulation of settlement authorizing JCP&L to implement its T1 EE&C Plan, as modified, for a three-year term (July 1, 2021 through June 30, 2024). In that same order, the Board further approved the recovery of T1 EE&C Plan costs and the revenue impact of sales losses resulting from the Plan through a component of JCP&L's Rider Regional Greenhouse Gas Initiative Recovery Charge ("Rider RRC") and Rider Lost Revenue Adjustment Mechanism Charge ("Rider LRAM"), respectively.

By Order dated May 24, 2023, the Board directed each electric and gas utility to propose energy efficiency and peak demand reduction programs for Triennium 2 ("T2") by October 2, 2023, a deadline that was later extended to December 1, 2023. By Order dated October 25, 2023, the Board found it was reasonable, prudent, and in the public interest to provide additional time for Board Staff ("Staff") and the New Jersey Division of Rate Counsel ("Rate Counsel") to conduct a thorough and diligent concurrent review of the T2 filings, as well as to provide parties and interested stakeholders with additional time to review, analyze, and discuss the filings. The Board thus ordered that the T2 Programs would commence on January 1, 2025, concluding on June 30, 2027. The Board further directed each electric and gas utility to file a letter petition to extend its T1 Programs, without changes, by six months to December 31, 2024, requiring that the extension: (1) meet energy savings targets equivalent to 50% of the utility's Program Year 3 ("PY3") targets; and (2) include a budget that does not exceed 50% of the utility's PY3 budget.

JCP&L is seeking recovery of T1 EE&C Plan costs, including the costs of the extension period, through its 2023 Rider RRC filing in BPU Docket No. ER24020075. JCP&L will also seek recovery of the revenue impact of sales losses resulting from the Plan through future Rider LRAM filings. Since JCP&L is seeking and will seek recovery in separate filings, JCP&L's Petition results in no immediate impact on any customer's bill and is strictly for approval for the Board-ordered extension of the T1 Program.
